PEOPLES GAS SYSTEM'S MOTION TO CORRECT A SCRIVENER'S ERROR

Peoples Gas System ("Peoples"), by and through its undersigned attorneys, and hereby makes this Motion to Correct a Scrivener's Error and in support thereof states:

1. On September 1, 2021, Peoples filed its Petition for Approval of 2020 True-Up, The Projected 2021 True-Up and 2022 Revenue Requirements and Surcharges associated with Cast Iron/Bare Steel Pipe Replacement Rider, by Peoples Gas System. On the last line of page 5 of the Petition, Peoples stated that "Projected capital expenditures for replacements during 2022 are \$29,917,839". That number is in error. The correct number should be \$27,291,015.

2. The correct figure of \$27,291,015 is accurately stated in Exhibit C, page 1 of 2, to the Petition. Peoples inadvertently used the number for "Clearings to Plant" rather than "Eligible Replacement - Mains".

WHEREFORE, Peoples moves this Honorable Commission for an order reflecting the correct figure of \$27,291,015 as the correct amount for Projected Capital Expenditures for Replacements during 2022 on page 5 of its Petition.
