Dear Mr. Bernier and Mr. Langley:

By this letter, Commission staff respectfully requests that City of Winter Park and Duke Energy Florida, LLC (DEF), the joint petitioners, provide responses to the following questions.

- 1. Paragraph 4 of the petition states that "certain Winter Park customers (currently being served temporarily by DEF) are being transferred to DEF". Referring to paragraph 4 in the proposed amendment to the territorial agreement, states that "there are no customers to be transferred from Winter Park to DEF..." Please explain and reconcile the difference.
- 2. Paragraph 3 of the proposed amendment to the territorial agreement states that 11 DEF customers (commercial and residential) will be transferred to Winter Park. Please state if the affected customers have been contacted and differences in electric rates explained pursuant to Rule 25-6.0440(1)(d), F.A.C. Additionally, please provide sample copies of

the notification letters sent to the commercial and residential customers that includes an explanation of the differences in rates.

- 3. Please state the timeframe to transfer the 11 customers pursuant to the proposed amendment to the territorial agreement.
- 4. Pursuant to Rule 25-6.0440(1)(e), F.A.C., please discuss the degree of acceptance by the affected customers.
- 5. Please discuss if any electric facilities will be transferred to serve the 11 customers subject to transfer in this proposed amendment.
