As FP&L customers in Bradenton, FL, we would like to comment on the projected minimum bill increase from approx. \$10 to approx. \$25 in the FP&L projected rate increase.

This is an exorbitant increase of 250% which will be shouldered mainly by solar power customers, such as ourselves, who are providing pollution free electricity for ourselves and also to our community with excess power created by our solar panels going back into the grid and being used by our neighbors.

Not only is this electricity 100% clean but it replaces the "dirty" electricity that would normally be generated by FP&L's mostly pollution creating power plants.

Also, although we are given a credit on our bill for any excess power that we send back to the grid, which is equal to the normal FP&L charge making it a wash, any excess left in our reserve at the end of the year is refunded as a credit on our bill BUT at a rate that is 85% LESS than FP&L resells it for! Why not have FP&L increase our credit to more closely reflect it's actual worth?
