GENERAL SUBJECT MATTER TO BE CONSIDERED: Docket No. 20210168-TP - Petition of North American Numbering Plan Administrator on behalf of the Florida telecommunications industry, for approval of consensus decision to recommend to the Commission an all-services overlay as the form of relief for the 561 numbering plan area.
