2	CHAIRMAN CLARK: All right. The next item up
3	is a panel, Item No. 9. The panel includes myself,
4	Commissioner La Rosa, and Commissioner Passidomo.
5	For reminder, we will return in 15 minutes

8	All right. Ms. Osborn, please introduce the
9	item.
10	MS. OSBORN: Good morning, Commissioners.
11	Stefanie-Jo Osborn for staff.
12	Item 9 is staff's recommendation regarding
13	both the utility's motion for partial summary final
14	order and a motion to dismiss application by a
15	potential customer in a proposed service area.
16	The utility has requested oral argument on its
17	motion. No request for oral argument was made on
18	the motion to dismiss. Staff recommends that oral
19	argument is not necessary with ei with respect
20	to either motion and that both motions should be
21	denied.
22	Marty Friedman, representing the utility, is
23	here in person and would like to address the
24	Commission, and is available to answer questions.
25	Brad Kelsky, representing Palm Island Estates

1	Association, Inc., is on the phone and would like
2	to address the Commission, and is available to
3	answer questions.
4	Linda Cotherman is on the phone and available
5	to answer questions.
6	And staff is also available to answer
7	questions.
8	CHAIRMAN CLARK: All right. Thank you very
9	much, Ms. Osborn.
10	I am a little bit, I guess, concerned here
11	about before we take a vote on whether or not we
12	are going to allow this.
13	Mr. Friedman, I I have one I want to
14	allow you to address the Commission. I do not want
15	to get into any merits of what the case is. I
16	would give you just a minute or so to introduc
17	to discuss why you want an oral argument.
18	Other than that, I would like to hold that for
19	the hearing. I assume you wanted to do that?
20	MR. FRIEDMAN: I I certainly want oral
21	argument, yes, Mr. Chairman.
22	CHAIRMAN CLARK: Okay. But you don't need to
23	make a case for your oral argument, I take it.
24	MR. FRIEDMAN: Well, I I do. I mean, I
25	think I think that you would welcome any

1	opportunity to have some party explain their
2	position in light of the fact that these motions
3	are are unique.
4	They're they're not often granted, but yet,
5	this is one of those rare circumstances where I
6	think that, once you hear the argument, you will
7	agree that it fits within that exception.
8	CHAIRMAN CLARK: I I'm gonna just I'm
9	gonna just turn this over to fellow Commissioners
10	to see whether they want to hear oral arguments or
11	not. I know we've had an opportunity to review the
12	information.
13	Anybody want to
14	COMMISSIONER La ROSA: Sure. Thank you,
15	Chairman. I personally think we have enough
16	information (technical interruption) oral argument.
17	(Discussion off the record.)
18	COMMISSIONER La ROSA: I personally think that
19	we have enough information to not have to hear oral
20	arguments.
21	CHAIRMAN CLARK: Commissioner Passidomo.
22	COMMISSIONER PASSIDOMO: Yeah, I, likewise,
23	would agree with you, Commissioner La Rosa. I
24	mean, I've read the pleadings and I think staff has
25	laid out a well-written recommendation in this

1 case. 2. CHAIRMAN CLARK: I'll entertain a motion. 3 COMMISSIONER PASSIDOMO: I -- I move that we 4 accept staff's recommendation. 5 CHAIRMAN CLARK: Deny oral argument. 6 COMMISSIONER La ROSA: Second. 7 CHAIRMAN CLARK: I have a motion and a second. 8 Any discussion? 9 All in favor, say aye. 10 (Chorus of ayes.) 11 CHAIRMAN CLARK: Any opposed? 12 Motion carries. Thank you. 13 That concludes agenda conference All right. 14 for today --15 MS. HELTON: Mr. -- Mr. --We'll resume within -- I'm 16 CHAIRMAN CLARK: 17 sorry. 18 MS. 19	CHAIRMAN CLARK: Okay. Great.
20	All right. Anything else to come before us at
21	this time?
