Joint Petition for Approval of Modification to Territorial Agreement in Orange County, by the City of Winter Park and Duke Energy Florida, LLC.

1. Paragraph 3 of the proposed amendment to the territorial agreement states that 11 DEF customers (9 commercial and 2 residential) will be transferred to Winter Park and that they are listed in new Exhibit F. However, Exhibit F lists only seven customers to be transferred from DEF to Winter Park. Please provide the corrected Exhibit F.

RESPONSE:

A corrected "Exhibit F" is attached.

There are vacant lots that were not included on the original Exhibit F (as there are no customers) that would transfer to the City of Winter Park should the amendment to the territorial agreement be approved. At this time, there have been no requests for service at these vacant lots, and the Parties will inform the FPSC should a service request be initiated during this review process. The vacant lots are expected to be one residential service and three commercial services.

2. If the above revision would result in further modifications to the updated maps Exhibits A, B, and E, please provide those revised maps.
