ORDINANCE # 350

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MOORE HAVEN, FLORIDA, AMENDING ORDINANCE 283, CHAPTER 115, ARTICLE II, SECTIONS 115-8 AND 115-9 OF THE MOORE HAVEN CITY CODE BY UPDATING CERTAIN RATES OF THE CITY'S ELECTRIC UTILITY RELATED TO RESIDENT SERVICE AND COMMERCIAL SERVICES; PROVIDING A SAVINGS CLAUSE; REPEALING ALL ORDINANCES IN CONFLICT HEREWITH; PROVIDING FOR AUTHORITY TO CODIFY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Moore Haven, Florida (the City) has not changed its residential service and commercial services electric rates since the enactment of Ordinance 283 in October 2005;

WHEREAS, the City Council desires to provide for the necessary costs of the City's electric utility to provide safe, reliable, and responsible electric service and to provide the customers of the City's electric utility with the lowest possible costs for that electric service;

WHEREAS, the State of Florida and the United States of America are currently experiencing a tremendous increase in prices of many items needed by everyone in the City for daily life, including energy costs;

WHEREAS, the City's adoption of this ordinance is required to comply with, and is expressly authorized by Florida law, including, but not limited to, part I of chapter 166, Florida Statutes;

WHEREAS, this ordinance relates both to the budget of the City and a revenue source necessary to fund the budget, as the City's electric utility operations are contemplated in the City's budget to provide a key source of revenue for the City; and

WHEREAS, the City Council hereby finds and determines that the adoption of this ordinance is necessary and appropriate to provide for the City's electric utility operations, and for ensuring the continued low cost of those electric utility operations, which are vital to promoting, enabling, and facilitating the City's provision of economic competitiveness for its residents, businesses, and visitors.

NOW, THEREFORE, BE IT ENACTED BY THE PEOPLE OF THE CITY OF MOORE HAVEN, FLORIDA, AS FOLLOWS:

- **SECTION 1. INCORPORATION OF RECITALS**. The above recitals are true and accurate and are hereby incorporated herein and made a material part of this ordinance.
- **SECTION 2. AMENDMENT TO SECTION 115-8**. Chapter 115, Article II, Section 115-8 of the Code of Ordinances of the City of Moore Haven, Florida, entitled "Residential service," is hereby amended as follows:
- (i) The monthly customer charge, set forth in section 115-8(D.)(1), is hereby amended by deleting "\$8.50" and replacing it with "\$9.14."
- (ii) The charge per each kWh, set forth in section 115-8(D.)(2), is hereby amended by deleting "\$0.0748" and replacing it with "\$0.080410."
- **SECTION 3. AMENDMENT TO SECTION 115-9**. Chapter 115, Article II, Section 115-9 of the Code of Ordinances of the City of Moore Haven, Florida, entitled "Commercial services," is hereby amended as follows:
- (i) The monthly customer charge for general service non-demand, set forth in section 115-9(C.)(1)(a), is hereby amended by deleting "\$8.50" and replacing it with "\$9.14."
- (ii) The charge per each kWh for general service non-demand, set forth in section 115-9(C.)(1)(b), is hereby amended by deleting "\$0.0879" and replacing it with "\$0.094493."
- (iii) The monthly customer charge for general service demand, set forth in section 115-9(C.)(2)(a), is hereby amended by deleting "\$33.50" and replacing it with "\$36.01."
- (iv) The charge per each kWh for general service demand, set forth in section 115-9(C.)(2)(b), is hereby amended by deleting "\$0.0483" and replacing it with "\$0.051923."
- (v) The charge per each kw, 20 kw minimum, for general service demand, set forth in section 115-9(C.)(2)(c), is hereby amended by deleting "\$9.05" and replacing it with "\$9.728750."
- **SECTION 4. SAVINGS CLAUSE.** If any section, paragraph, sentence, clause, phrase, or work of this Ordinance shall be held unconstitutional,

invalid, or unenforceable, such holding shall not affect any of the remaining portions hereof.

SECTION 5. REPEAL OF CONFLICTING ORDINANCES. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 6. AUTHORITY TO CODIFY. Specific authority is hereby granted to codify this Ordinance.
