**COMPLAINT INFORMATION**

Complaint: Other Complaint against Florida Power & Light Company  
Details:

"A new minimum base bill of \$25, which was approved by the Florida Public Service Commission is now in effect for the metered residential customers whose monthly base electric service costs fall below \$25."

I own a duplex in which I have two meters, one for each unit. I live in one side and the other is used by me for storage. The bill for the side I use for storage had an average monthly bill between \$16-\$18. I find that the PSC has approved an unfair base charge of \$25 plus taxes, which now results in a bill almost twice that, \$31.47 to be exact. This is not in keeping with trying to conserve electricity. Instead, it only encourages someone like me to use more electricity "to get my money's worth". As a retiree of modest means, this approved base rate places an undue financial burden on me and others like me. The service address for this unit is 3500 SW 92nd Ave Miami 33165 - Account no. 30132-10236.

In the unit I live in, service address: 3502 SW 92 Ave Miami 33165 - Account no. 60251-63418 has also seen an increase. Same time last year I used 750 KWh the bill was \$86.00; this year, while I managed to save electricity and use 703 KWh, my bill was \$94.33. We are seeing inflationary challenges everywhere - gas, food, services - but to approve a minimum

base charge is not well thought out and insensitive to those with limited means. I hope the PSC will reconsider their action.
