8	Electric's petition on approval of a new compliance
9	project, the cost recovery through the
10	Environmental Cost Recovery Clause.
11	The project is for modifications at the
12	company's Big Bend Station to comply with the
13	Environmental Protection Agency's Clean Air Act
14	national emissions standards for hazardous air
15	pollutants specific to stationary gas-fired
16	combustion turbines.
17	The estimated five-year projected cost of the
18	project is approximately 1.1 million. However,
19	prudency of the costs will be reviewed when
20	submitted for recovery.
21	Staff recommends that the project is necessary
22	to comply with an environmental regulation and
23	meets the Commission's criteria for recovery
24	through the cost Environmental Cost Recovery
25	Clause.
