Staff's modification replaces pages 2 of 5 and 3 of 5 of Attachment D with the attached revised pages. Attachment D shows the present and recommended interim rates for the four utilities. For Chesapeake only, the recommendation as filed shows the recommended interim transportation charges for all rate classes with two decimals. However, Chesapeake's tariff shows transportation charges with three decimals. Attached are the revised pages 2 of 5 and 3 of 5 of Attachment D showing the staff-recommended interim rates for Chesapeake with three decimals. The rates have been calculated correctly; showing the rates with three decimals ensures the Commission's decision will match Chesapeake's tariff. For the other three utilities, the recommendation correctly shows all recommended interim transportation charges with three decimals.

These changes do not alter staff's recommendation or calculations.
