Florida Power & Light Company ("FPL") hereby submits this letter in response to the Joint Post-Hearing Brief of the Office of Public Counsel ("OPC") and Florida Industrial Power Users Group ("Group") filed in the above referenced docket (hereinafter, the "Joint Brief").

FPL submits that the argument set forth on pages 17-23 of the Joint Brief is procedurally improper. At its core, this section of the Joint Brief is really seeking reconsideration of the Florida Public Service Commission's unanimous decision on August 3, 2022, that denied OPC's prior oral request for reconsideration of Order No. PSC-2022-0292-PCO-EI. (See Tr. vol 5, 798-818.) There is no procedural mechanism to make such a request and, in fact, doing so is prohibited. See Rule 25-22.0376(1), F.A.C. ("The Commission shall not entertain a motion for reconsideration of an order disposing of a motion for reconsideration").

Accordingly, FPL hereby notifies the Commission that it agrees with and supports the thorough and well-reasoned conclusion reached in Order No. PSC-2022-0292-PCO-EI, which was confirmed by unanimous vote of the Commission and is now the law of the case.
