RE: Confidential Classification of Document No. 03282-2023

On June 5, 2023, Duke Energy Florida, LLC (Duke) filed its initial request for confidential treatment for Document No. 03282-2023 in Docket No. 20230035-EI.¹ This document contains confidential information provided in response to OPC's first set of interrogatories, No. 5 and first set of production of documents (PODs), No. 4. The confidential information consists of listing the name of the industrial customer involved and information associated with the industrial customer's non-fuel revenue for a specific project.

In its initial request for confidentiality, Duke asserts that the responses provided on the temporary territorial variance contains confidential information relating to competitive business interests, the disclosure of which would impair the competitive business of the provider of the information. Duke further stated that the document also contains confidential information, the disclosure of which would impair Duke's efforts to contract for goods or services on favorable terms.² Specifically, the material contains a non-fuel revenue analysis spanning a ten year period as well as naming the industrial customer. In addition, Duke states that the utility treats the highlighted information provided in Document No. 03514-2023 as confidential.

Staff has reviewed the document and concurs with Duke that the nature of the information continues to meet the requirements set forth in Section 366.093(3)(d) and (e), Florida Statutes, whereby disclosure of this information would impair the competitive business operations of Duke. Therefore, staff recommends that the request by Duke for confidential classification of certain information in Document No. 03282-2023 be approved.
