3	we will move to Item No. 8 on the Agenda this
4	morning, presented by Mr. Smith.
5	Mr. Smith, you are recognized.
6	MR. SMITH: Thank you. Good morning,
7	Commissioners.
8	Item No. 8 is St. Joe Natural Gas System's
9	petition for approval of its 2022 depreciation
10	study.
11	Rule 25-7.045 requires natural gas public
12	utilities to file a comprehensive depreciation
13	study with the Commission for review at least once
14	of five years from the submission date of the
15	previous study, or pursuant to Commission order.
16	Staff has reviewed St. Joe's depreciation
17	study and recommends minor changes to certain
18	account's depreciation parameters. St. Joe is in
19	agreement with staff's recommendation.
20	Staff's recommended changes resulted in an
21	increase to St. Joe's annual depreciation expense
22	of \$49,003.
23	Thank you.
24	COMMISSIONER GRAHAM: Okay. Great. Thank
25	you, Mr. Smith.

1	All right. Commissioners, you have a summary
2	on Item No. 8. I will entertain any comments or a
3	motion on that item.
4	COMMISSIONER CLARK: Move to approve, Chair
