Attached for filing in the above docket on behalf of Tampa Electric Company ("the company") is the company's Revised Preliminary List of Issues and Positions, which was originally filed on August 25, 2023.

In the August 25, 2023 Preliminary List of Issues and Positions, the company indicated that, at that time, the company had not competed the analysis to determine the other clause factors that are utilized to calculate and establish Tampa Electric's Price Responsive Load Management program ("RSVP-1") rates for the January through December 2024 period. The company indicated in its original Preliminary List of Issues and Positions that it would file the proposed RSVP-1 rates based upon the company's 2024 projected clause amounts for the ECCR, Fuel and Purchase Power Cost Recovery, Capacity Cost Recovery and Environmental Cost Recovery Clauses after those factors were calculated. The company has now completed all the other clause factors utilized to calculate and establish the RSVP-1 rates for the January through December 2024 period and is included the proposed RSVP-1 rates in this revised Preliminary List of Issues and Positions.

TAMPA ELECTRIC COMPANY'S PRELIMINARY LIST OF ISSUES AND POSITIONS

Tampa Electric Company ("Tampa Electric" or "the company"), hereby submits its Preliminary List of the Issues and Positions to be taken up at the hearing scheduled to commence on November 1, 2023 in the above docket.

GENERIC CONSERVATION COST RECOVERY ISSUES

ISSUE 1: What are the final conservation cost recovery adjustment true-up amounts for the period January 2022 through December 2022?

<u>Tampa Electric's Position</u>: A net over-recovery of \$4,521,911, including interest. (Witness: Roche)

ISSUE 2: What are the appropriate total conservation adjustment actual/estimated true-up amounts for the period January 2023 through December 2023?

<u>Tampa Electric's Position</u>: An over-recovery of \$2,841,279, including interest. (Witness: Roche)

<u>ISSUE 3</u>: What are the appropriate total conservation adjustment true-up amounts to be collected/refunded from the period January 2024 through December 2024?

Tampa Electric's Position: A refund of \$7,363,190, including interest. (Witness: Roche)

ISSUE 4: What are the total conservation cost recovery amounts to be collected during the period January 2024 through December 2024?

Tampa Electric's Position: \$39,011,038. (Witness: Roche)

ISSUE 5: What are the conservation cost recovery factors for the period January 2024 through December 2024?

<u>Tampa Electric's Position</u>: For the period January 2024 through December 2024 the cost recovery factors for the rate design and cost allocation as put forth in Docket No. 20210034-EI are as follows:

ISSUE 6: What should be the effective date of the new conservation cost recovery factors for billing purposes?

Tampa Electric's Position: The factors should be effective beginning with the specified conservation cost recovery cycle and thereafter for the period January 2024 through December 2024. Billing cycles may start before January 1, 2024, and the last cycle may be read after December 31, 2024, so that each customer is billed for 12 months regardless of when the factor became effective. (Witness: Roche)

ISSUE 7: Should the Commission approve revised tariffs reflecting the energy conservation cost recovery amounts and energy conservation cost recovery factors determined to be appropriate in this proceeding?

<u>Tampa Electric's Position</u>: Yes. The Commission should approve revised tariffs reflecting the energy conservation cost recovery factors determined to be appropriate in this proceeding. (Witness: Roche)

COMPANY SPECIFIC CONSERVATION COST RECOVERY ISSUES

ISSUE 8: What is the Contracted Credit Value for the GSLM-2 and GSLM-3 rate riders for Tampa Electric Company for the period January 2024 through December 2024?

<u>Tampa Electric's Position</u>: In accordance with Order No. PSC-2021-0423-S-EI, issued November 10, 2021 in Docket No. 202100034, the Contracted Credit Value by Voltage Level for the forthcoming cost recovery period, January 2024 through December 2024, for the GSLM-2 and GSLM-3 rate riders will be:

ISSUE 9: What are the residential Price Responsive Load Management (RSVP-1) rate tiers for Tampa Electric Company for the period January 2024 through December 2024?
