

# Line 610 – Functionality in Emergency Situations

47 C.F.R. § 54.313(a)(1) requires a high-cost support recipient to certify that it is "able to function in emergency situations as set forth in § 54.202(a)(2)." Section 54.202(a)(2) requires that each eligible telecommunications carrier ("ETC") must "demonstrate its ability to remain functional in emergency situations, including a demonstration that it has a reasonable amount of back-up power to ensure functionality without an external power source, is able to reroute traffic around damaged facilities, and is capable of managing traffic spikes resulting from emergency situations."

TracFone, SAC 219003, as a wholly owned subsidiary of Verizon, hereby certifies that it is able to function in emergency situations for those TracFone customers utilizing the Verizon Wireless network. In support of this certification, TracFone states that Verizon Wireless has deployed sufficient power generators throughout its network and also has the capability to deploy temporary microwave facilities quickly to the extent necessary for Verizon Wireless' network to remain functional during emergencies. These generators and microwave facilities ensure that (1) a reasonable amount of back-up power will be available to ensure functionality without an external power source; (2) Verizon Wireless will be able to reroute voice traffic around damaged facilities; and (3) Verizon Wireless will be capable of managing spikes in voice traffic resulting from emergency situations.

In addition to the Verizon Wireless network, TracFone also provides service using the networks from other leading wireless companies, including AT&T Mobility and T-Mobile. As such, TracFone will be able to function in emergency situations to the extent that the other underlying network providers are able to do so. TracFone relies on those networks' reliability in all situations, including emergency situations. To the best of our knowledge, those companies comply with applicable FCC requirements for emergency service, including power supplies.
