DUKE ENERGY FLORIDA, LLC'S SECOND REQUEST FOR EXTENSION OF CONFIDENTIAL CLASSIFICATION

Duke Energy Florida, LLC, ("DEF" or "Company"), pursuant to Section 366.093, Florida Statutes (F.S.), and Rule 25-22.006, Florida Administrative Code (F.A.C.), submits this Second Request for Extension of Confidential Classification (the "Request") for certain information contained in Exhibit No. ___(TH-1) to the direct testimony of Terry Hobbs filed in this docket on July 10, 2019 and Amended on July 16, 2019. In support of this Request, DEF states:

- 1. On July 10, 2019, DEF filed a Request for Confidential Classification for certain information provided in Exhibit No. __(TH-1) to the direct testimony of Terry Hobbs. DEF amended this request on July 16, 2019 (document no. 05588-2019). Exhibit No. ___(TH-1) contains "confidential proprietary business information" under Section 366.093(3), Florida Statutes.
- 2. DEF's July 16, 2019 Amended Request was granted by Order No. PSC-2019-0380-CFO-EI on September 17, 2019. On March 10, 2021, DEF filed its First Request for Extension of Confidential Classification which was granted by Order No. PSC-2022-0238-CFO-EI on June 27, 2022. The period of confidential treatment granted by that order will expire on December 27, 2023.

The information continues to warrant treatment as "proprietary confidential business information within the meaning of Section 366.093(3), F.S. Accordingly, DEF is filing its Second Request for Extension of Confidential Classification.

- 3. DEF submits that the information contained in Exhibit No. ___(TH-1) identified in Exhibit "A" and Exhibit "C" to the July 16, 2019, Amended Request¹ continues to be "proprietary confidential business information" within the meaning of section 366.093(3), F.S. and continue to require confidential classification. *See* Affidavit of Gene Flavors, Jr. at ¶¶4-6 attached as Revised Exhibit "D". This information is intended to be and is treated as confidential by the Company. The information has not been disclosed to the public. Pursuant to section 366.093(1), F.S., such materials are entitled to confidential treatment and are exempt from the disclosure provisions of the Public Records Act. *See* Affidavit of Gene Flavors, Jr. at ¶¶ 7-8.
- 4. Nothing has changed since the issuance of Order No. PSC-2019-0380-CFO-EI to render the information stale or public such that continued confidential treatment would not be appropriate. Upon a finding by the Commission that this information continues to be "proprietary confidential business information," it should continue to be treated as such for an additional period of at least 18 months and should be returned to DEF as soon as the information is no longer necessary for the Commission to conduct its business. *See* §366.093(4), F.S.

WHEREFORE, for the foregoing reasons, DEF respectfully requests that this Second Request for Extension of Confidential Classification be granted.

AFFIDAVIT OF GENE FLAVORS, JR. IN SUPPORT OF DUKE ENERGY FLORIDA, LLC'S FIRST REQUEST FOR EXTENSION OF CONFIDENTIAL CLASSIFICATION

BEFORE ME, the undersigned authority duly authorized to administer oaths, personally appeared Gene Flavors, Jr., who being first duly sworn, on oath deposes and says that:

- 1. My name is Gene Flavors, Jr. I am over the age of eighteen (18) and I have been authorized by Duke Energy Florida, LLC (hereinafter "DEF" or the "Company") to give this affidavit in the above-styled proceeding on DEF's behalf and in support of DEF's Request for Confidential Classification ("DEF's Request"). The facts attested to in my affidavit are based upon my personal knowledge.
- 2. I am the General Manager for the Decommissioning of the DEF Crystal River Unit 3 Nuclear Plant (the CR3 Facility).
- 3. As the General Manager, I am responsible for ensuring that Accelerated Decommissioning Partners and Duke Energy Florida comply with their contractual obligations during the decommissioning of the CR3 Facility and that Duke Energy Florida meets its reporting obligations to the Florida Public Service Commission.

- 4. DEF is seeking its second extension of confidential classification for certain information contained in Exhibit No. ____(TH-1), to his direct testimony filed in this docket on July 10, 2019 and Amended on July 16, 2019. There are no changes to the information contained in DEF's confidential Exhibit A, redacted Exhibit B, and justification matrix C. The referenced Exhibits are on file with the Clerk. DEF is requesting its second extension of confidential classification of this information because it contains competitively sensitive commercial confidential business information, the disclosure of which would impair DEF's efforts to contract for goods or services on favorable terms.
- 5. The confidential information at issue relates to commercially sensitive and contractual obligations pertaining to the terms and conditions set forth in a contract between DEF, ADP CR3, LLC and ADP SFI, LLC for decommissioning activities related to the accelerated decommissioning of the CR3 Facility, including information from the transaction, such as pricing. The disclosure of such information would not only impair the Company's competitive business advantages but would also violate contractual requirements. DEF is obligated to maintain the confidentiality of this information under the subject contract, and therefore it qualifies for confidential classification.
- 6. DEF negotiates with contracting parties to obtain competitive contracts that provide economic and other benefits to DEF's customers. If DEF cannot assure contracting parties that it can maintain the confidentiality of contractual terms, those parties and other similarly situated parties may forego entering contracts with DEF, which would impair the Company to negotiate such contracts on favorable terms.
- 7. The information identified as Exhibit A is intended to be and is treated as confidential by the Company. With respect to the information at issue in DEF's Request, such information has not been disclosed to the public, and the Company has treated and continues to treat such information as confidential.
- 8. Upon receipt of its own confidential information, strict procedures are established and followed to maintain the confidentiality of the terms of the documents and information provided, including restricting access to those persons who need the information to assist the Company, and restricting the number of, and access to the information and contracts. At no time since receiving the information in question has the Company publicly disclosed that information.

The Company has treated and continues to treat the information at issue as confidential.
