NOTICE OF INTENT TO REQUEST CONFIDENTIAL CLASSIFICATION**

Tampa Electric Company ("TECO" or "the company"), pursuant to Section 366.093, Florida Statutes, and Rule 25-22.006(3)(a), Florida Administrative Code, hereby files this Notice of Withdrawal Without Prejudice of its Intent to Request Confidential Classification for portions of PricewaterhouseCoopers' ("PwC") Audit Workpapers for Hurricane Ian ("Confidential Material").

On December 15, 2023, TECO filed a Notice of Intent to Request Confidential Classification for portions of PwC Audit Workpapers for Hurricane Ian. *See* DN 06611-2023. Staff ultimately did not request copies of any of PwC's Audit Workpapers. As a result, TECO withdraws its initial Notice of Intent without prejudice. If Staff later serves Tampa Electric with a request for production for any of the Audit Workpapers, the company will file a Request for Confidential Classification covering those documents.


