7 Alara Kaymak on behalf of Commission staff.

8 Item 5 is a joint petition by Florida Public  
9 Utilities Company and Peoples Gas Systems  
10 requesting approval of Amendment No. 1 to the  
11 Amended and Restated Territorial Agreement in Pasco  
12 County.

13 Specifically the joint petitioners seek to  
14 transfer the area identified in the petition's  
15 Exhibit A as Service Area B from of FPUC to Peoples  
16 Gas with no changes to the terms and conditions of  
17 the existing agreement.

18 The joint petitioners represent that Service  
19 Area B is an area with new commercial development,  
20 and that FPUC is unable to extend service to the  
21 area economically, whereas, Peoples has specialties  
22 nearby and is willing and able to serve the  
23 development economically.

24 Staff notes that there are no current customer  
25 or facility transfers that will result under this

1 proposed territorial agreement. Staff recommends  
2 approval of this joint petition.


