1 PROCEEDINGS 2 CHAIRMAN LA ROSA: All right. Let's move on 3 to Item No. 7. 4 MS. RAMIEREZ-ABUNDEZ: Good morning, 5 Commissioners. My name is Ailynee Ramirez-Abundez of the Engineering staff. 6 7 Item No. 7 is a petition for approval of a 8 revised purchased power agreement between Tampa 9 Electric Company and Pasco County for cost 10 recovery. 11 TECO negotiated a purchased power agreement 12 for the purchase of firm capacity and energy with 13 Pasco from its waste to energy facility. The 14 contract will sell 18 megawatts of firm capacity in 15 energy to TECO for a 10-year contract beginning on 16 January 1st, 2025. 17 Power will be transmitted from Pasco's facility through Duke Energy Florida's transmission 18 19 line to interconnection point with TECO. 20 TECO projects 7.3 million in savings based on 21 its current fuel and load forecasts. 22 Staff has reviewed the petition and recommend 23 the PPA to be approved for cost recovery. The 24 negotiated PPA improves TECO's fuel diversity and 25 the addition of renewable energy, appears

1 cost-effective based on current forecasts and has
2 adequate security and performance guarantees to
3 protect ratepayers. In addition, the company will
4 not seek cost recovery for any transmission studies
5 or upgrades.

No public comments have been filed in the
docket, and staff and TECO with Pasco are available
for questions.

9 CHAIRMAN LA ROSA: Thank you for the summary.
10 Members, are there any questions or comments?
11 Questions or comments?

12 Commissioner Clark, you are recognized. 13 COMMISSIONER CLARK: Just one quick question. 14 It's an 18-megawatt contract for energy and 15 capacity. Is that the full rating of the facility, 16 or any idea? Normally, you don't get 100 percent 17 of energy with matching capacity like that. That's 18 kind of -- I am assuming the energy number may be 19 different than the full 100 percent capacity -- I 20 am saying this wrong -- it would be -- that would 21 carry the energy. 22 MS. RAMIEREZ-ABUNDEZ: If I am correct, Yes. 23 Pasco has 31 megawatts, but they are asking for 18

24 megawatts.
