WITHLACOOCHEE RIVER ELECTRIC COOPERATIVE, INC.**


Pursuant to Article IV, Section 4.1 of the Territorial Agreement between Withlacoochee River Electric Cooperative (“WREC”) and Tampa Electric Company (“Tampa Electric”), as approved in Order No. 23905 issued in Docket No. 900752-EU on December 26, 1990, this filing will serve as Tampa Electric’s report on the status of such agreement.

On March 1, 2022, the Commission voted to approve a modification to the territorial boundary between the utilities, but all other aspects of the agreement remain unchanged.

This is to advise the Commission that the subject territorial agreement remains in full force and effect and that the parties have encountered no disputes concerning the provision of such agreement.
