RE: Request for Tariff Filing revisions by North Florida Community Water Systems – Okaloosa water system in Okaloosa County – Private Fire Protection and Meter Installation

Dear Commission Clerk:

North Florida Community Water Systems (NFCWS) hereby submits its tariff filing to add private fire protection charges and meter installation charges for meters larger than 5/8 x ¾" for the Okaloosa water system in Okaloosa County. The former Okaloosa Waterworks, Inc. was granted its grandfather certificate in Order No. PSC-2020-0402-PAA-WU, issued October 26, 2020.

Recently, NFCWS has had an inquiry by a General Service Customer to install two (2) one-inch (1") meters, as well as to provide private fire protection. Currently, the Okaloosa water system only has a meter installation charge for a $5/8 \times 3/4$ " meter. Typically, meters larger than this size are installed at Actual Cost. The Sunny Hills water system, also under the North Florida Community Water System Tarriff No.19.6 reflects the Actual Cost for All other meters larger than $5/8 \times 3/4$ ". This is consistent with similar charges approved by the Florida Public Service Commission.

For Private Fire Protection, these charges are pursuant to Rule 25-30.465, Florida Administrative Code, which is one-twelfth (1/12) the base facility charge for the corresponding meter size. Typically, these start at a 4" and go up as large as a 10".

The requested tariff revisions are attached hereto.
