Good evening,

My name is Jose Solares and I am the founder of Solares Consulting Corporation. I retired from Florida Power & Light (FPL) on January 31, 2016. Shortly after founding my company, I began consulting for the Warren Henry Auto Group which at the time was located at 20800 NW 2 Ave in Miami, Florida.

At that location, we installed 6 EV chargers, and FPL's response and support in providing service to these chargers was excellent.

Currently, Warren Henry's Corporate headquarters are located at 2300 NE 151 St. Miami, Florida, in a state of the art facility we designed and built in 2019. The building spans seven floors and over 700,000 square feet, with infrastructure capable of supporting 175 EV chargers as demand grows. We represent automotive brands, including Jaguar, Land Rover, Infiniti, and Lincoln.

As part of my role, I monitor and analyze our electrical consumption, and regularly coordinate with FPL to stay updated on new programs and system improvements. I work closely with our customer advisor, Mrs. Tania Romero, to identify any opportunities for efficiency or to address potential service concerns. FPL's reliability, responsiveness, and collaboration has been exceptional, enabling us to continually improve our electric service and take advantage of the latest offerings.

In addition to our headquarters, we also operate dealerships in South Dade, Broward County, and Naples, as well as two locations outside FPL's service territory. This email specifically refers to our experience within FPL's coverage area.

In South Dade, we operate a Jaguar Land Rover dealership.
