TracFone Wireless, Inc. (TracFone) hereby notifies the Commission that it has changed its name to Verizon Value, Inc. (Verizon Value). Verizon Value is a prepaid wireless service provider that has been designated as an eligible telecommunications carrier under the company's former name.

Verizon Value's new name was registered with the Florida Department of State on April 9, 2025, as reflected in the attached certificate. The name change does not alter the company's corporate structure, management or business operations. Because the company will continue to do business as TracFone, the branding of its stores, websites, advertising and services are unaffected by the new name. The name change thus will be transparent to customers. The company's principal business address remains at 9700 Northwest 112 Ave., Miami, Florida 33178.

TracFone respectfully requests that the Commission change its ETC designation to reflect the new name: Verizon Value, Inc.

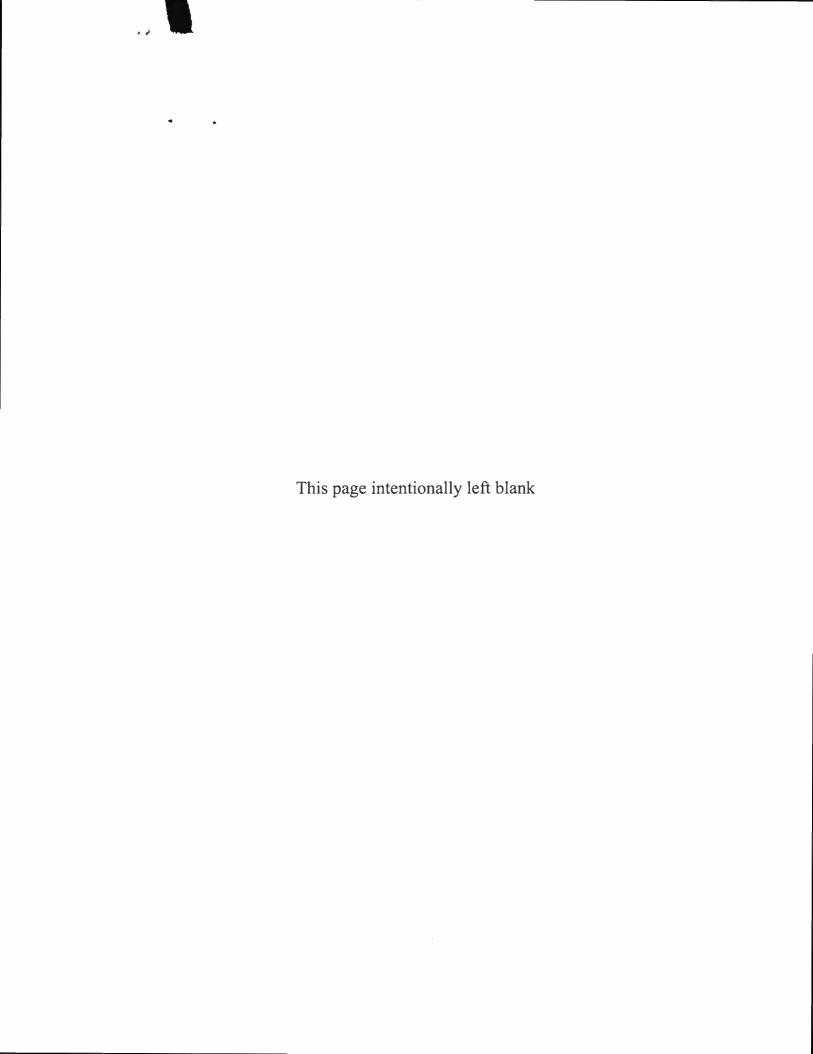
