Pursuant to Section 366.093 of the Florida Statutes, and Rule 25-22.006, Peoples Gas System, Inc. (PGS) requests confidential classification of certain highlighted information contained in responses to OPC's 2nd request for PODs, OPC's 3rd request for PODs, and answers to OPC's 3rd set of interrogatories. More specifically, this information has to do with contractor costs and projected financial targets, none of which is publicly available.

Based on staffs review, the information provided that is related to the highlighted information contained in responses to OPC's 2nd request for PODs, OPC's 3rd request for PODs, and answers to OPC's 3rd set of interrogatories contains information regarding competitive interests and disclosure of this information would impair competitive business interests. Therefore, staff recommends that the request for confidentiality of certain information included in Document No. 03390-2025 be approved pursuant to Section 366.093(3)(d) and (e), F.S.
