On June 4, 2025, Peoples Gas System, Inc. (Peoples) filed a request for confidential treatment of Document No. 04311-2025. This document contains Peoples' financial analysis of a contract for Amazon Web Services.

In its request for confidentiality, Peoples contends that the document contains information concerning bids or other contractual data, the disclosure of which would impair Peoples' ability to contract for goods and services. Peoples also contends the document contains information related to their competitive interests, the disclosure of which would impair their competitive business. Furthermore, Peoples asserts that the Company treats the highlighted information provided in Document No. 04311-2025 as private and has not publicly disclosed it.

Staff has reviewed the document and concurs with Peoples that the nature of the information meets the requirements set forth in Section 366.093(3) (d), and (e), Florida Statutes, whereby disclosure of the information would impair its competitive business interests. Therefore, staff recommends the request by Peoples for confidential classification of Document No. 04311-2025 be approved.
