The FLORIDA PUBLIC SERVICE COMMISSION announces a hearing in the following docket to which all persons are invited.

DOCKET NO. AND TITLE: 20240155-EI - Petition for approval of accounting treatment for the transfer of proportional share of Plant Daniel Units 1 and 2 to Mississippi Power Company, by Florida Power & Light Company.

The Commission may rule on any such motions from the bench or may take the matters under advisement. This proceeding shall: (1) allow the parties the opportunity to present evidence and/or arguments in support of their positions; (2) allow for such other purposes as the Commission may deem appropriate.
