4	Staff.
5	MR. QUIGLEY: Good morning, Commissioners. I
6	am Scott Quigley with the Division of Accounting
7	and Finance.
8	Item 3 is staff's recommendation in Docket No.
9	20250059 regarding Florida City Gas' request for
10	the approval to change the allowance for funds used
11	during construction rate, or the AFUDC rate, from
12	5.85 percent to 7.72 percent.
13	The docket title reflects an AFUDC rate change
14	from 5.85 percent to 7.72 percent. However, the
15	Commission is voting on the approval of staff's
16	recommendation to change the rate to 7.65 percent.
17	Staff reviewed Florida City Gas' request and
18	confirmed the company's calculations comply with
19	the requirements of Rule 25-7.0141. Due to a
20	revision in the company's long-term debt cost rate,
21	staff determined the correct AFUDC rate is 7.65,
22	and recommends the approval of all issues.
