1 P R O C E E D I N G S

2 CHAIRMAN LA ROSA: Let's now move to Item No.

3 9. Mr. Davis, you are recognized, sir.

4 MR. DAVIS: Good morning, Commissioners.

5 Item 9 is a petition by Duke Energy for a
6 SoBRA base rate adjustment. Paragraph 16 of the
7 2024 Duke Energy Settlement Agreement allows for
8 the inclusion into base rates of up to 900
9 megawatts of solar generation. Duke Energy Florida
10 is seeking approval of four solar projects
11 collectively referred to as the First SoBRA
12 Tranche, which consists of approximately 300
13 megawatts of total installed capacity from the
14 following solar facilities: Sundance in Madison
15 County; Rattler in Hernando County; Half Moon in
16 Sumter County; and Bailey Mill in Jefferson County.

17 The Commission's decision is limited based on
18 the 2024 settlement regarding the reasonableness
19 and the cost-effectiveness of the solar generation
20 projects.

21 Staff recommends that the Commission approve
22 this petition and allow for the cost of these solar
23 projects to be included in base rates through the
24 SoBRA mechanism.

25 Staff also recommends the Commission to give

1 staff administrative authority to approve tariffs
2 and associated charges for each of the solar
3 projects.

4 This docket should remain open pending receipt
5 of Duke Energy letters confirming commercial
6 operation for each of the solar projects.

7 Staff is available for questions.

8 CHAIRMAN LA ROSA: Thank you for the summary.

9 Commissioners, any questions are or discussion
10 on Item No. 9? Questions or discussion?

11 Seeing none, open for a motion.

12 COMMISSIONER CLARK: Move approval, Mr.


