Dear Florida Public Service Commissioners,

As a Florida Power & Light (FPL) customer, I strongly oppose the largest rate increase in U.S. History. This excessive hike would place an unfair burden on customers, especially low-income customers or older adults on fixed incomes who simply cannot afford to pay more.

With costs for housing, healthcare, and everyday essentials already high, the last thing I need is a higher electric utility bill.

FYI - My condo association fees have skyrocketed in recent years to an insane amount that exceeds my mortgage (which I must pay until I'm 79) & real estate taxes combined! This is primarily because insurance premium hikes due to hurricanes & the shocking condo collapse not far from here in Surfside.
