
**FLORIDA PUBLIC UTILITIES COMPANY'S NOTICE OF SUBSTITUTION OF

Florida Public Utilities Company ("FPUC" or "Company"), by and through its undersigned attorney, hereby notifies the Florida Public Service Commission ("Commission") of the need to substitute a witness in this proceeding. In support thereof, the Company hereby states that:

1. FPUC filed the direct testimony of Brittnee Baker on April 4, 2025 (True Up), along with Exhibit BB-1 sponsored by Ms. Baker, which was subsequently revised on May 2, 2025.


