I am deeply concerned about the proposed rate increase. Our home has brand new windows & insulation as of 2024. We have a new AC system (2023) and we maintain the temperature in our home at 78 degrees. We follow the FPL off peak hours when utilizing items that require more power. Our bill remains over \$300 per month for 2 people. We are on a fixed income, and I am 100% disabled. I have owned my home since 2005. For the past 20 years, there are always increases in cost of living, but one constant remains unacceptable - the consistent brown outs. These are not only frustrating but are affecting the quality and lifespan of our appliances and electronics. We have brought this to your attention countless times over the past two decades, yet FPL states this is not an issue or a concern. You may feel this is normal, but I cannot afford to replace all these items sooner than I should have to. If this rate increase goes into effect, you are going to render our older generation homeless as they will not be able to afford the cost to live in our great state. I would have expected a decrease with all the self sufficiency the new government has put in place. the generation costs should be lower, not exponentially higher.
