Subject: Formal Complaint Regarding TECO Electric's Pricing and Monopoly Practices

To Whom It May Concern:

I am writing to express my deep concern and strong dissatisfaction with the current billing practices and pricing structure of TECO Electric. As a Florida resident and consumer of regulated utility services, I am appalled by the dramatic increase in my monthly electric bill, which has now exceeded \$700 per month—an amount that is absolutely unsustainable for a **single-occupant household**.

I live alone and keep my air conditioning set at 80 degrees—well above average for comfort—because I am fearful of the financial burden of my monthly electric bill. Despite these extreme conservation measures, my bill has risen from over \$600 to now \$700 a month, which is inexplicable and alarming.

I respectfully request that my billing history be thoroughly reviewed and explained, specifically how such charges are justifiable for a one-person household that is consciously limiting energy usage.

Furthermore, I take serious issue with the fact that consumers have no choice in their electricity provider. TECO maintains a monopoly in this region, and by every reasonable and legal interpretation, such a lack of competition in the utility market is unacceptable. Monopolistic control of essential services violates the principles of fair competition and consumer rights, and I call on the Florida Public Service Commission to take immediate action to address this.

The current pricing model being permitted by TECO is not only financially oppressive but unsustainable for the average resident. The people of Florida deserve transparency, accountability, and most importantly—options. The time has come to open the electricity market to competitive providers and put an end to unchecked price hikes enabled by monopolistic control.

I trust the Commission, whose members are appointed to serve the public interest, will investigate this matter thoroughly and hold TECO accountable for their unjust pricing. I also request a direct response addressing the specific charges on my account and the broader issue of market fairness and pricing regulation.

Thank you for your attention to this urgent and important matter.

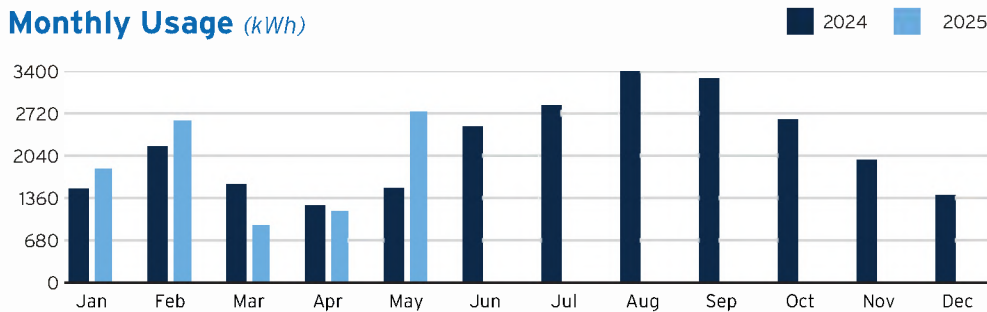

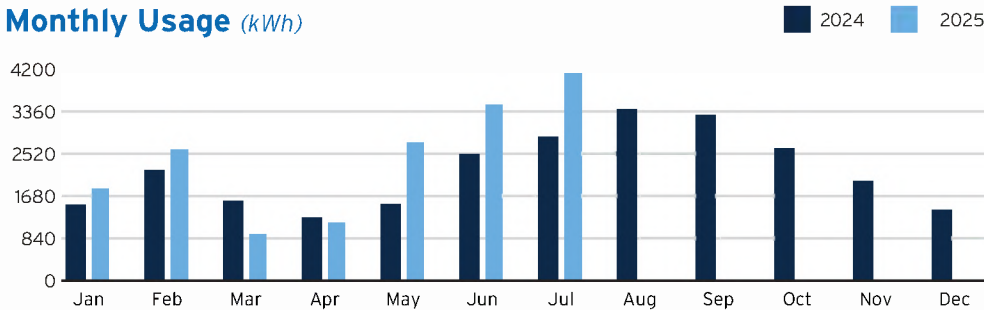
