Based on staff's review, the information provided that is related to the highlighted portions of late-filed Exh 5 to the deposition transcript of Timothy O'Connor contains information regarding competitive interests, as well as information concerning bids or other contractual data, Specifically, the USB contains information about PGS's third party damages success rate. The disclosure of this information would impair PGS's competitive business interests and the efforts of PGS to contract for goods or services on favorable terms.

Staff has reviewed the document and concurs with PGS that the nature of the information meets the requirements set forth in Section 366.093(3)(d)(e), F.S. Therefore, staff recommends that the request for confidentiality of certain information included in Document No. 04460-2025 be approved.
