So doing dishes is minimal. I usually only have one lamp on in the evenings. And I unplug everything when I leave my home and I am gone for hours out for the day due to Dr appts and tests and taking care of my special needs daughter who lives in an ALF in Tampa and having to run errands and also take her to Dr appts and therapies. So I am not home at least 3 days a week during the day. I am a disabled retired who's only income is my Social Security!! And I'm sure this speaks for many in our state! How can we afford to use electricity???? I'm appalled and panicked!!! How am I supposed to be able to pay for Internet as Spectrum also raised their rates! I need Internet to handle my and my daughters affairs! And that's what I have for TV is Internet! How can a retiree who also has to pay the riding costs of Medicare Premiums and copays(and now they will be going up even higher with Big Beautiful Bill! ☹️) when I already can't afford my copays this year? My MRI copays went up from \$10 to \$75!!! And they will go up even higher along with my specialists in 2026. How is any retiree supposed to be able to live in this country like this???? And there is no one fighting for us to keep our costs down!!! Shame on you!
