On July 8, 2025, Peoples Gas System, Inc. (PGS) filed a request for confidential treatment of Document No. 05502-2025. This document contains copies of Emera Board Minutes and presentations provided in PGS's Supplemental Response to OPC's First Request for Production of Documents, (No. 36).

In its request for confidentiality, PGS contends that the document contains information concerning competitive business interests, the disclosure of which would impair their competitive business of the provider of the information. Furthermore, PGS asserts that it treats the highlighted information provided in Document No. 05502-2025 as private and has not publicly disclosed it.

Staff has reviewed the document and concurs with PGS that the nature of the information meets the requirements set forth in Section 366.093(3)(e), Florida Statutes, whereby disclosure of the information would impair its competitive business interests. Therefore, staff recommends the request by PGS for confidential classification of Document No. 05502-2025 be approved.
