AND ENVIRONMENTAL CONFEDERATION OF SOUTHWEST
FLORIDA'S FOURTEENTH REQUEST FOR PRODUCTION OF
DOCUMENTS (Nos. 95, 122-123 AND 125)**

Pursuant to Section 366.093, Florida Statutes, and Rule 25-22.006, Florida Administrative Code, Florida Power & Light Company ("FPL") hereby requests confidential classification of certain documents and information provided in its responses to Florida Rising, League of United Latin American Citizens and Environmental Confederation of Southwest Florida's ("FL Rising") Fourteenth Request for Production of Documents (Nos. 95, 122-123 and 125) ("Confidential Information"). In support of its request, FPL states as follows:

1. FPL served its responses to FL Rising's Fourteenth Request for Production of Documents (Nos. 94-133) on July 17, 2025. Consistent with Rule 25-22.006, Florida Administrative Code, this request is being filed contemporaneously with the service of those responses to request confidential classification of certain information contained therein.

2. The following exhibits are attached to and made a part of this Request:

a. Exhibit A consists of a copy of the confidential documents. As the documents are confidential in their entirety and include voluminous electronic files, the documents in Exhibit A are being provided electronically on an electronic storage device.

- b. As the documents in Exhibit A are confidential in their entirety, Exhibit B consists of identifying cover pages identifying the Bates numbers of the confidential documents in Exhibit A.
- c. Exhibit C is a table that identifies the information for which confidential treatment is being sought, references the specific statutory basis for the claim of confidentiality, and identifies the declarants who supports the requested classification.
- d. Exhibit D consists of the declarations of Liz Fuentes and James Coyne in support of this Request.

3. FPL submits that the Confidential Information is intended to be and has been treated and maintained by FPL as confidential business information, and its disclosure would cause harm to FPL and its customers. Pursuant to Section 366.093, Florida Statutes, such materials are entitled to confidential treatment and are exempt from the disclosure provisions of the public records law. Thus, once the Commission determines that the information in question is proprietary confidential business information, the Commission is not required to engage in any further analysis or review such as weighing the harm of disclosure against the public interest in access to the information.

4. As described more fully in the declarations included in Exhibit D, some of the Confidential Information contains information concerning bids or other contractual data, the disclosure of which would impair the efforts of FPL to contract for goods or services on favorable terms. Specifically, the materials contain information related to negotiated consulting services agreements and invoices. In addition, some of the Confidential Information consists of proprietary confidential business information relating to competitive interests, the disclosure of which impair the competitive business of the provider of the information. Specifically, the

information is data that is proprietary to third-party vendors who provided it to Concentric pursuant to a subscription agreement. This information is protected by Sections 366.093(3)(d) and (e), Florida Statutes.

5. Upon a finding by the Commission that the Confidential Information is proprietary and confidential business information, the information should not be declassified for at least eighteen (18) month period and should be returned to FPL as soon as it is no longer necessary for the Commission to conduct its business. *See* Section 366.093(4), Florida Statutes.

WHEREFORE, for the above and foregoing reasons, as more fully set forth in the supporting materials, Florida Power & Light Company respectfully requests that its Request for Confidential Classification be granted.


