Dear Mr. Teitzman:

On July 28, 2025, Peoples Gas System, Inc. filed rebuttal testimony in the above-referenced docket and therein proposed removing municipal facilities relocation costs from the rate case revenue requirement so those costs can be recovered through the Natural Gas Facilities Relocation Cost Recovery Clause.
