**FLORIDA POWER & LIGHT COMPANY'S NOTICE OF  
SUBSTITUTION OF WITNESS AND ADOPTION OF TESTIMONY**

Florida Power & Light Company ("FPL" or the "Company") provides notice to the Florida Public Service Commission and parties of record that FPL witness Michael Jarro will be adopting the prepared direct and rebuttal testimony filed by Mr. Eduardo De Varona. To promote administrative efficiency for this change, FPL states as follows:

1. Contemporaneous with the filing of this notice, FPL will file errata to Mr. De Varona's prepared direct and rebuttal testimony. The errata will make no substantive changes to the testimony originally filed by Mr. De Varona. Aside from correcting a minor typographical error, it will only reflect necessary changes to the name, title, qualification, and experience portions of Mr. De Varona's testimony to reflect that information for Mr. Jarro.

2. The prepared direct and rebuttal testimony of some of FPL's other witnesses, as well as the testimony of intervenor witnesses, contain references to the prepared direct testimony of Eduardo De Varona. Rather than updating and refileing each of those other testimonies, it should be understood by virtue of this notice that all references to the testimony of Eduardo De Varona in testimony of any other witness in this docket will be references to Mr. Jarro's testimony.

3. Mr. De Varona is identified as sponsor or co-sponsor of a number of minimum filing requirement ("MFR") schedules submitted by FPL on February 28, 2025. The portions of those schedules that had been sponsored by Mr. De Varona will be sponsored by Mr. Jarro.

4. As part of the discovery process, the Company has served answers to interrogatories that were sponsored or co-sponsored by Mr. De Varona. Mr. Jarro hereby sponsors each and every such discovery response.

5. Some of the answers to interrogatories served on the parties refer to the prepared direct testimony of Mr. De Varona or his exhibits. Rather than updating those interrogatory answers, it should be understood by virtue of this notice that all references to the testimony of Mr. De Varona or his exhibits will be references to Mr. Jarro's testimony or exhibits.

6. FPL notes that Mr. De Varona was deposed twice in this docket. Mr. Jarro adopts all statements made in those depositions.
