Dear Governor DeSantis,

I am concerned that the electric power supply in Florida is shrinking?

Why?

Over the next 10 years, 91% of all new power generation will be solar and battery storage. Solar is 5 to 6 times more expensive than natural gas, clean beautiful coal or nuclear. Yet these power plants can run ALL day long.

The peak solar energy from our sun is from 9:30 AM to 4:30 PM and on average only 5.3 hours of sun/day in Florida.
