Pursuant to Section 366.093 of the Florida Statutes, and Rule 25-22.006, Florida Administrative Code, Florida Power & Light Company (FPL) requests confidential classification of certain highlighted information provided in corrected response to FL Rising, LULAC, and ECOSWF's 8th request of production of documents No. 69.

Based on staffs review, the information provided in the corrected response to FL Rising, LULAC, and ECOSWF's POD No. 69 contains information concerning bids or other contractual prices, the disclosure of which would impair the efforts of FPL to contract for goods or services on favorable terms. Specifically, the response contains pricing data related to a negotiated contract price with a vendor. Therefore, staff recommends that the request for confidentiality of certain information included in Document No. 04033-2025 be approved pursuant to Section 366.093(3)(d), F.S.
