## Dear Commissioners.

My residence of 11 years is 5041 Sherwood Lane, Haines City, FL, which is located in the community of Grenelefe and I pay for water from Grenelefe Utility.

Scott House, owner of Grenelefe Utility, worked with the residence of Grenelefe to produce a redevelopment plan for Grenelefe. After many meetings and much input from the residents, a plan was drawn and presented for approval to the Polk County Board of Commissioners. Part of the plan was that new home builders/owners would cover the cost for renovation of the water treatment plant and connection of the new developments through a CDD. He provided all the necessary documents and data needed to be approved for this undertaking. The Polk County Board of Commissioners approved this plan.

As a home owner and resident of Grenelefe I am asking the Florida Public Service Commission to abide by the aforementioned agreement with the Polk County Board of Commissioners which allows the use of a CDD which will be paid by the new builders and home owners

Allowing this to happen would mean we have Water Bills HIGHER than almost anywhere in the country. Our property values are at risk, and who, with a modest or low income can afford utility bills of \$500.00 plus. In addition current homeowners already paid for capacity once in our home purchase.

Allowing this also means that the builder of new homes in Grenelefe stands to profit on the backs of current owners and renters. Many renters work hard for low incomes and will not be able to pay their utility bills.
