Dear Florida Public Service Commissioners,

I am a residential customer of Florida Power & Light (FPL) and a member of AARP, and I oppose FPL's attempts to raise its rates even higher than they already are. I opposed the increases FPL proposed in February, and I oppose the nearly identical increases FPL has now put forward with its corporate partners in a so-called "Settlement" negotiated in secret. These rates remain excessive and unfair to residential customers.

The reality is that even though I work very hard to conserve on energy, turning off my AC when I leave the house and any other time I can, opening my windows to cool off my house when it's cooler outside, turning off lights and appliances not in use, etc etc etc, nevertheless my FPL bill continues to go up and up and up! I always compare this month's bill to the same month a year ago, and it is consistently higher, no matter what other factors there are. FPL is already receiving excessive and unreasonable compensation.

And rather than implementing more conservation and more solar energy capacity, which would be the most economical and most in the customers' interest, they just keep wanting to build more nuclear plants, THE MOST EXPENSIVE AND DANGEROUS FORM OF ENERGY ON THE PLANET! The ONLY reason they want to do it is that it's more profitable for them. It DOES NOT BENEFIT us ratepayers in any way, but just takes more dollars out of OUR pockets and puts them right into FPL's pockets.

ENOUGH ALREADY! NO MORE RATE INCREASES FOR FPL! WE NEED RATE RELIEF!!! PLEASE LISTEN TO THE PUBLIC INSTEAD OF FPL FOR A CHANGE! THE PSC is SUPPOSED TO act on our behalf, but rarely ever does.

FPL's claim that this "Settlement" represents residential customers like me is false. No one from FPL ever consulted me, asked for my input, or received my consent to speak on my behalf. Instead, FPL chose to ignore the voices of ordinary Floridians who have already expressed strong opposition to these increases.

I call on the Public Service Commission to reject these secret deals cut with large industrial and commercial interests and to hold FPL accountable.

Enough is enough — protect residential customers from corporate greed and unjustified rate hikes.
