

FAR NOTICE OF HEARING

PUBLIC SERVICE COMMISSION

The FLORIDA PUBLIC SERVICE COMMISSION announces a hearing in the following docket to which all persons are invited.

DOCKET NO. AND TITLE: 20250011-EI - Petition for base rate increase by Florida Power & Light Company

HEARING DATES AND TIMES: Monday, October 6, 2025 at 9:30 a.m. Tuesday, October 7 through Friday, October 10, 2025, and Monday, October 13 through Friday, October 17, 2025, have been reserved for continuation of the hearing if needed. The starting time of the next day's session will be announced at the conclusion of the prior day. The hearing may be adjourned early if all testimony is concluded.

PLACE: Room 148, Betty Easley Conference Center, 4075 Esplanade Way, Tallahassee, Florida.

GENERAL SUBJECT MATTER TO BE CONSIDERED AT THE HEARING:

The purposes of this hearing are to receive testimony and exhibits and to take final action relative to the Petition for Base Rate Increase by Florida Power & Light Company filed February 28, 2025, and the Joint Motion for Approval of Settlement Agreement filed August 20, 2025, and to take action on any motions or other matters that may be pending at the time of the hearing. The Commission may rule on any such motions from the bench or may take the matters under advisement. This proceeding shall: (1) allow the parties to present evidence and testimony in support of their positions; (2) allow for such other purposes as the Commission may deem appropriate.

All witnesses shall be subject to cross-examination at the conclusion of their testimony. The hearing will be governed by the provisions of Chapter 120, Florida Statutes, Chapter 366, Florida Statutes, and Chapters 25-6, 25-22 and 28-106, Florida Administrative Code.

EMERGENCY CANCELLATION OF HEARING

If settlement of the case or a named storm or other disaster requires cancellation of the proceedings, Commission staff will attempt to give timely direct notice to the parties.
