Tuesday, October 7 through Friday, October 10, 2025, and Monday, October 13 through Friday, October 17, 2025, have also been reserved for continuation of the hearing if needed. The starting time of the next day's session will be announced at the conclusion of the prior day. The hearing may be adjourned early if all testimony is concluded.

PURPOSE AND PROCEDURE

The purpose of this hearing is to consider the Petition for Base Rate Increase by Florida Power & Light Company filed February 28, 2025, the Joint Motion for Approval of Settlement Agreement filed August 20, 2025, and any motions or other matters that may be pending at the time of the hearing. The Commission may rule on any such motions from the bench or may take the matters under advisement.

At the hearing, all parties shall be given the opportunity to present testimony and other evidence on the 130 issues identified in Order No. PSC-2025-0298-PHO-EI issued August 7, 2025, and the 29 major elements established in Order No. PSC-2025-0345-PCO-EI issued September 12, 2025. All witnesses shall be subject to cross-examination at the conclusion of their testimony.
