• When the *Motion to Intervene* was filed on 6/9/25 (DN 04340-2025) your email address was indicated as: schef@gbwlegal.com

- This past Friday, 9/19/25, a couple of testimonies were rejected for correction and refiling (Efiling ID Nos. 42724 and 42725). The emails related to those rejections were returned to CLK as undeliverable. The email address that was entered when the documents were efiled was: schef@gbkwlegal.com
- On the same day, the testimonies were corrected, refiled, and accepted (Efiling ID Nos. 42731 and 42732), and those emails appear to have been delivered to you at schef@gbkwlegal.com without issue.
