


AWI is agreeable to these stipulations being entered into the record, subject to the Commission's approval, and Florida Rising, LULAC, ECOSWF, and OPC are agreeable to waiving cross-examination of Witness Jason Simmons. The foregoing stipulations are provided

in lieu of cross-examination that Florida Rising, LULAC, ECOSWF, and OPC would otherwise conduct of Witness Jason Simmons and do not change the position of any of the Movants. Accordingly, the Movants request that the Commission excuse Mr. Simmons from appearing at the hearing.

The Movants have conferred with all parties regarding this motion and no party objects or takes a position. Specifically, the following parties do not object to the motion and do not object to Mr. Simmons being excused from appearing at the hearing: Florida Power and Light Company and Florida Energy for Innovation Association. The following parties take no position: the Commission Staff, Electrify America, Floridians Against Increased Rates, the Fuel Retailers, Walmart, Inc., the Southern Alliance for Clean Energy, EVgo, the Florida Industrial Power Users Group, the Florida Retail Federation, and the Federal Executive Agencies.

WHEREFORE, Florida Rising, LULAC, ECOSWF, OPC, and AWI respectfully move the Commission to approve this stipulation and to enter it into the record of this docket, and to excuse Mr. Simmons from appearing at this hearing.
