FAR NOTICE OF SECURITIES APPLICATION

The Florida Public Service Commission (Commission) will consider at its October 7, 2025 Agenda Conference, Docket No. 20250100-EI, Application for authority to issue and sell securities during calendar years 2026 and 2027 pursuant to Section 366.04, F.S., and Chapter 25-8, F.A.C., by Florida Power & Light Company (FPL). FPL seeks Commission approval to: (a) issue, sell, and/or exchange any combination of long-term debt and equity securities and/or to assume liabilities or obligations as guarantor, endorser, or surety in an aggregate amount not to exceed \$8.6 billion during calendar year 2026; and (b) issue and sell short-term securities in an amount or amounts such that the aggregate principal amount of short-term securities outstanding at the time of, and including, any such sale shall not exceed \$5.6 billion during calendar years 2026 and 2027.

DATE AND TIME: Tuesday, October 7, 2025. The Agenda Conference begins at 9:30 a.m., although the time at which this item will be heard cannot be determined at this time.

PLACE: Commission Hearing Room 148, Betty Easley Conference Center, 4075 Esplanade Way, Tallahassee, Florida.

PURPOSE: To take final action in Docket No. 20250100-EI, Application for authority to issue and sell securities during calendar years 2026 and 2027 pursuant to Section 366.04, F.S., and Chapter 25-8, F.A.C., by FPL.
