5 Item No. 8 is DEF's petition for approval of
6 Duke's new negotiated contract with Placid Solar,
7 LLC, which would allow Placid to sell as-available
8 energy to DEF.

9 The negotiated contract is fundamentally
10 similar to DEF's current Commission-approved
11 as-available energy tariff with modifications made
12 to account for Placid's status as a renewable
13 generating facility.

14 Staff has reviewed DEF's filing and believes
15 it to be consistent with the contract rules
16 pursuant to rules 25-17.087 and .825, F.A.C., and
17 DEF should be allowed to seek cost recovery through
18 the fuel clause -- the fuel and purchase power cost
19 recovery clause.

20 Staff is available for any questions.
