13	agreement in Polk County.
14	The joint petitioners executed the proposed
15	agreement on June 30th, 2025, to modify their
16	existing 1991 agreement and formalize permanent
17	service assignments for two greenfield
18	subdivisions, Cadence Crossing Phase II and
19	Schaller Preserve.
20	No existing customers will be transferred
21	under the agreement as the parcels at issue are
22	either unserved or were previously subject to
23	temporary arrangements.
24	The proposed agreement eliminates the
25	potential for uneconomic duplication of facilities.

1	It does this by aligning service to the
2	subdivisions in question with existing proximate
3	infrastructure, thereby supporting operational
4	efficiencies and providing long-term clarity to the
5	utilities' revised territorial boundaries.
6	Staff recommends approval of this joint
7	petition. Thank you.
