Your responses are truly appreciated.

Many, including myself, are confused as to the "staff recommended rates" section of the proposal (attached). This docket shows a "current rate", "interim rate" and the "staff recommended rate".

Which were \$2.93 (interim) to \$7.38 Interim to \$37.11 Recommended per 1,000 gallons

This is the "PSC staff" that is recommending this rate increase, am I correct?

In comparison, I pulled the documents related to the Sunshine rate increase that the PSC granted in May (attached). That shows only a "current rate" and a "proposed rate".

Which were \$5.59 (current) to \$6.48 "proposed". Ultimately, the PSC granted Sunshine the \$6.48 "proposed" rate.

If we assume our interim rate is reasonable @ \$7.38 per 1,000 gallons (.90 more than the recent increase granted to Sunshine in May) the \$37.11 is a little more than 5 times the interim \$7.38.

Let's compare that to the price of gasoline-

Average 1 gallon price today in FL is \$3.02, this 5X's multiple would bring the price of gasoline to \$15 a gallon!

Except, there's an option with gasoline as you can always go buy an EV, there is not an option with water, you must have water flowing through your pipes!

Help us understand how and why any PSC staff would recommend such an outrageous increase?

Dear Mr. Deterding:

By this letter, the Commission staff requests that NC Real Estate Projects, LLC d/b/a Grenelefe Utility (Grenelefe or Utility) provide responses to the following data request:

- 1. It is staff's understanding that in order for Grenelefe to secure a loan to finance its proforma projects, the Utility requires approval of its service availability charges. Please state whether the Utility has secured a loan following the Commission's approval of the Utility's service availability charges at the September 4, 2025 Agenda Conference.
- 2. If the response to Data Request No. 1 is in the affirmative, please respond to the below questions:
  - a. Please provide the name of the bank or financial institution from which the loan was secured.
  - b. Please provide the amount of the loan.
  - c. Please provide the interest rate of the loan.
  - d. Please provide the terms of the loan.
  - e. Please provide any supporting documentation from the financial institution related to the issuance of the loan.

- 3. If the response to Data Request No. 1 is in the negative, please respond to the below questions:
  - a. Please explain what steps have been taken, if any, to secure the loan.
  - b. Please identify when the Utility expects the loan to be secured.
  - c. Please state whether any expectations regarding the loan or its interest rate have changed as a result of the Commission's approval of service availability charges or due to any other factors. If so, identify and describe each such change in detail.

In order to complete our analysis, staff needs the following documentation related to non-potable water services for the test year:

- 4. Please provide an allocation for each of the following expenses: salaries and wages; payroll taxes; associated taxes other than income; purchased power; contractual services; and any other expenses related to non-potable water.
- 5. Please identify specific National Association of Regulatory Utility Commissioners account number(s) of any plant items related to non-potable water and, if applicable, its allocation between potable and non-potable. Please specify if plant items are shared between potable and non-potables.
- 6. Please provide the revenue amounts associated with both potable and non-potable water.
- 7. Please provide the number of gallons sold split between potable and non-potable water.
- 8. Pursuant to Rule 25-30.565(2)(h), Florida Administrative Code (F.A.C.), please provide a detailed statement defining the capacity of the treatment facilities in terms of equivalent residential connections (ERCs) as used in developing the proposed service availability charges for both water and wastewater.
- 9. Pursuant to Rule 25-30.565(2)(j), F.A.C., please provide a list of outstanding developer agreements.
- 10. Pursuant to Rule 25-30.565(2)(k), F.A.C., for each developer agreement, please state whether the agreement is designed to result in contributed property, an estimated value of the contributed property to be added to the Utility's books, and a description of the property.
- 11. In response to Staff's Fourth Data Request, the Utility indicated that the home sites in the Smokey Groves Development by Lennar Homes have been prepared into finished lots with the distribution and collection systems fully constructed. Please elaborate on the Utility's statement that Lennar Homes is presenting its items for acceptance by NC Real Estate Projects, LLC.

- 12. Please explain in detail whether the requested pro forma items increase the design capacity (not permitted capacity) of the water and wastewater treatment facilities.
- 13. Please provide a service availability policy.
- 14. In the Utility's application for extension of territory, the Utility indicated it had 984 connections remaining in its existing territory and 1,080 connections in the new service area for a total of 2,064 connections. Based on the Utility's methodology of using only new connections in determining its service availability charge, please explain in detail why the Utility is only using 1,200 connections in its calculation of its connection charge.
- 15. Provide the design capacity (not permitted capacity) for the water treatment plant according to the Florida Department of Environmental Protection (DEP). As part of this response, provide all supporting documentation.
- 16. Provide the design capacity (not permitted capacity) for the wastewater treatment plant according to the DEP. As part of this response, provide all supporting documentation.
- 17. Explain what steps Grenelefe is currently taking, or is planning to take, to address the 46 percent EUW contained in the Staff Report.
- 18. Provide the rates the customers were being charged when Grenelefe was bought on May 22, 2022.
- 19. Provide the rates the customers were being charged when Grenelefe filed its application for a Staff-Assisted Rate Case on January 10, 2025.
- 20. Explain whether Grenelefe was aware, prior to the customer meeting, of the issues regarding excessive Boil Water Notices (BWN) expressed by customers at the customer meeting. If so, what actions has Grenelefe taken to reduce or eliminate the causes of the BWNs.
- 21. Explain whether Grenelefe was aware, prior to the Customer meeting, of the issues regarding sewage overflows entering customer's homes. If so, what actions has Grenelefe taken to correct the cause of those overflows?
- 22. Did Grenelefe reach out to each customer that commented at the customer meeting? If so, when was contact made, and how were the customer's concerns addressed? If not, please explain why.
- 23. Provide any documentation from the DEP that states the DEP is requiring the Utility to increase the permitted capacity of its wastewater treatment plant.
- 24. Refer to Grenelefe's response to Staff's First Data Request, No. 9. Explain why June 2024, July 2024, and August 2024 have the same amount of water usage for each day for

- each month in the Utility's Monthly Operation Reports. If this is incorrect, explain why and if the DEP has been made aware of this.
- 25. Refer to Grenelefe's response to Staff's Fourth Data Request, No. 17. Provide a copy of the entire "ALTERNATIVES ANALYSIS FOR TREATMENT PLANT EXPANSION AND UPGRADE For Grenelefe Resort Wastewater Treatment Plant Polk County, Florida" referenced in this response.
- 26. Provide an estimate of how long Grenelefe's proposed meter replacement program will take. As part of your response, please include an estimated beginning and ending date for the program.
- 27. Refer to Grenelefe's response to Staff's Fourth Data Request, No. 24. Provide a copy of the Well #10 hydro tank inspection report delivered to Grenelefe on August 28, 2025. As part of this response, provide who performed the hydro tank inspection.
- 28. In response to Staff's Fourth Data Request, No. 6. The Utility indicated its pro forma project to replace water valves would be completed by October 31, 2026. Provide the number of water valves that have been replaced since October 31, 2024.
- 29. Provide copies of the latest inspection reports for all 5 lift stations. As part of this response, provide who performed the lift station inspections.
- 30. Provide the name and position of the Grenelefe employees that would be assigned to the two requested trucks.
- 31. Provide the name and position of the Grenelefe employees that would be assigned to the three requested golf carts.
- 32. Grenelefe was required to file a proposal with the most feasible option to bring Total Nitrogen limit and Total Phosphorus limit into compliance regarding the Wastewater Treatment Plant with DEP prior to September 30, 2025. Please provide a copy of the proposal required to be filed.

Thanks and still looking forward to a reply. I read where the PSC recently (May 7th) approved an increase to Sunshine Water Services Company to charge \$6.48 per 1,000 gallons of water up to 8,000 gallons. For comparison purposes (below), this community is currently paying \$7.38 per 1,000 gallons, but the "staff recommended rate" on the docket is \$37.11 per 1,000 gallons? An 8,000 gallon month bill would go from \$84.16 to \$424.26? Is there another community in Florida anywhere near that? In the US even? This is a very old community that is mostly condo's that were previously resort rooms with an average value of around \$100,000, the homes in the area are around \$275,000-\$300,000. It was only a few years ago when this guy (Scott House) who owns this water company also bought the land that was the golf courses (plus he acquired 7 condo units in the deal) with his overall plan to develop the golf course land into more homes. He's currently under threat of being fined by the county for not maintaining the mowing of the grass that encroaches these homes and communities. He also stopped paying the home owner associations dues in January on the 7 properties he acquired as part of this overall deal. Attached is his affidavit. This a community of around 2,000 households that at least half are condos and most, if not all, are in a homeowner association. There are a lot of low income hard working families and low income retired individuals. A utility bill of this magnitude would collapse the association's as people would have to choose between paying their water bill or pay their association fees. The home values have already taken hits because this threat is out there and surely would make these homes unsellable when the sale would include outrageous water bills.

Please make a concerted effort to address this issue as I have found no one who can even fathom how this outrageous potential increase could be of consideration or a possibility in the first place.

## Dear Mr. Wagner:

Thank you for your continued engagement regarding Docket No. 20250023-WS (NC Real Estate Projects, LLC d/b/a Grenelefe Utility). We understand the depth of concern expressed by you and members of the community, and we appreciate your commitment to participating in this process. As previously noted, this docket remains under active review by the Commission's technical staff.

Regarding your broader questions about the rate increase request and the Commission's process: utilities are permitted to file rate requests under applicable statutes and rules, and those filings are subject to rigorous review by Commission staff, comprised of technical staff from our Engineering, Accounting, and Economics divisions and the Office of General Counsel. Chapter 367 of the Florida Statutes and Chapter 25-30 of the Florida Administrative Code is the controlling law that the Commission staff relies upon in its review of a water and wastewater utility's request. Specifically, Rule 25-30.455 addresses staff-assisted rate cases ("SARCs"). The Florida Legislature created a law that permits small utilities to seek recovery for costs through a process conducted by the Commission's staff. This is intended to provide more efficient regulation by minimizing rate case expense borne by the utility and passed on to customers. However, the inclusion of a request in a docket does not imply endorsement or approval; rather, it initiates a formal evaluation process that considers technical, financial, and legal factors, as well as public input. After considering the Staff Recommendation, the Commission will base its Proposed Agency Action (PAA) on the information gathered by Commission staff during their review. Rule 25-22.029 of the Florida Administrative Code provides more details about the PAA process and explains how substantially affected persons may request a hearing after the PAA is issued.

To clarify the current status of this docket: the Commission has made a decision related to interim rates and interim service availability charges at this time. **No final decision has been made regarding the utility's requested rates or charges**. The Staff Recommendation, once filed, will reflect the results of its comprehensive review and will be subject to consideration by the Commission. Because the docket remains open and under active review, we are not in a position to respond directly to the broader questions you have raised.

Once the Staff Recommendation is filed, it will be publicly available for review in the docket. At that time, you and other interested parties will have the opportunity to respond directly to the Staff Recommendation - either by submitting written comments to the Commission Clerk for inclusion in the docket, or by speaking directly to the Commission during the public portion of the Commission Conference.

Further, the Office of Public Counsel (OPC), established by the Florida Legislature in Section 350.061, Florida Statutes, is tasked with representing Floridians in proceedings before the Commission. At the last Commission Conference on this docket (regarding interim service availability rates) on September 4, 2025, Deputy Public Counsel Charles Rehwinkel indicated that this docket has OPC's attention and is being monitored. I have cc'ed Deputy General Counsel Rehwinkel on this email.

The Commission is actively listening to the concerns of the Grenelefe community. To date, over 200 letters and public comments from customers have been filed in the official docket, reflecting a broad range of perspectives and concerns. Additionally, several customers participated and spoke during the recent customer meeting. These contributions are an important part of the review process and are being considered alongside all other filings in this SARC. We recognize the seriousness of the concerns raised and assure you that all filings, including public correspondence and comments, will be taken into account.

Many, including myself, are confused as to the "staff recommended rates" section of the proposal (attached). This docket shows a "current rate", "interim rate" and the "staff recommended rate".

Which were \$2.93 (interim) to \$7.38 Interim to \$37.11 Recommended per 1,000 gallons

This is the "PSC staff" that is recommending this rate increase, am I correct?

In comparison, I pulled the documents related to the Sunshine rate increase that the PSC granted in May (attached). That shows only a "current rate" and a "proposed rate".

Which were \$5.59 (current) to \$6.48 "proposed". Ultimately, the PSC granted Sunshine the \$6.48 "proposed" rate.

If we assume our interim rate is reasonable @ \$7.38 per 1,000 gallons (.90 more than the recent increase granted to Sunshine in May) the \$37.11 is a little more than 5 times the interim \$7.38.

Let's compare that to the price of gasoline-

Average 1 gallon price today in FL is \$3.02, this 5X's multiple would bring the price of gasoline to \$15 a gallon!

Except, there's an option with gasoline as you can always go buy an EV, there is not an option with water, you must have water flowing through your pipes!

Help us understand how and why any PSC staff would recommend such an outrageous increase?

On June 28, 2024, Sunshine Water Services Company (Sunshine or Utility) filed an application with the Florida Public Service Commission (Commission or PSC) for increased water and wastewater rates for its customers in Charlotte, Highlands, Lake, Lee, Marion, Orange, Pasco, Pinellas, Polk, and Seminole Counties. Sunshine is a Class A utility providing service to 34,740 water and 28,892 wastewater customers.

#### OUESTIONS & ANSWERS

#### 1. Why is Sunshine requesting a rate increase?

Sunshine is requesting a rate increase to recover the cost of operating the Utility and allow the company an opportunity to earn a fair rate of return on its investment.

2. When was Sunshine's last approved rate increase? Sunshine's last rate case was in 2020.

# 3. Is there an opportunity for public input on this rate case?

Yes. As part of the evaluation process of Sunshine's rate request, Commission staff will conduct virtual and inperson service hearings to allow feedback about Sunshine's quality of service and the rate setting process. Comments will be reviewed before the Commission reaches a decision. Commissioners will attend and participate during the service hearings.
